5. INSTALLATION

Read entire label before using. Use only as directed. Test in a small inconspicuous area to determine required results. Be sure all surfaces to be cleaned are swept or vacuumed to remove loose debris. Avoid skin and eye contact with product. Wear protective eyewear, gloves, long sleeves, and long pants while handling concentrate. Ensure work area is well-ventilated during application and until surface is dry. Keep children and pets out of the area during application and drying.

Application

Temperature range must be between 40-100°F (4-38°C).

- 1. Apply sufficient material to thoroughly wet the surface.
- 2. Allow STONETECH® DEEPKELNZ™ to work on the surface for 5-10 minutes (do not allow product to dry on the surface)
- Lightly scrub with stiff bristle brush to remove the surface contaminants.
- 4. Rinse and wipe surface with clean cloth and warm water.
